### Dogfen Feature Intensive: Cinematic Documentary Development

#### Introduction

Emerging Welsh filmmakers and producer/director teams developing their first feature documentary can now apply for a place on the DOGFEN FEATURE INTENSIVE training programme, consisting of a weekend residential workshop for all, and a subsequent series of coaching sessions, for 6 film projects, fully funded by Media Cymru, Ymddiried and Ffilm Cymru, in partnership with DOGFEN.

Participants will be equipped with the tools and coaching they need to develop embryonic feature ideas into fundable development projects suitable for global theatrical audiences.

This unique two-day (2 night) workshop encourages participants to think cinematically and globally about their non-fiction prospects, learning in detail how film funders will assess their applications. In the company of experienced film professionals, we will explore the non-fiction film landscape and share insights into the techniques and strategies you need to conceptualise and communicate your ideas, so they are ready to submit to competitive national and international film development funds and the wider film market.

12 places are available in total, made up of emerging filmmakers and/or up to 6 producer / director teams.

- Producers can apply ONLY if they have a director on board.
- Solo Directors or P/Ds (Producer-Directors) can also apply but ideally we're looking for Producer and Director collaborations.
